# 1. Acceptance of these Terms and Conditions

- 1.1. This Website is provided by Durban Filmmart Institute NPC with registration number 2020/255768/08, a non-profit company (hereinafter referred to as "the NPC", "Durban Filmmart Institute", "we", "us" and "our").
- 1.2. Please read the Terms and Conditions carefully before you proceed to use the Site. By using the Site, or once you click to accept or agree to these Terms and Conditions, you accept and agree to be bound and abide by these Terms and Conditions.
- 1.3. If these Terms and Conditions are not accepted in full, the use of the Website must be terminated immediately.

## 2. Definitions
